

4. The term of appointment on the above three posts will be up to the age of 67 years and the applicants to be appointed will be allowed the salary and rent as prescribed under Uttar Pradesh Public Service Tribunal (Pay Scale, Allowances and Conditions of Service of Chairman, Vice-Chairman and Members) Rules, 2018.



कर्मचारी का आय और मुद्रांक में वृद्धि


